Honorable ambassador to the OAS: Mr. Francisco Mora

Our organization, BTN, representing thousands of affiliated and exiles Nicaraguan Americans asks for your help to carry out a consensus with the ambassadors of the allied nations that share the same democratic and human rights values in order to expel Nicaragua from the Organization of American States (OAS).

Through this letter we address you as our representative in the Organization of American States (OAS). We sadly feel that the OAS has remained inert in the face of the aberrant ideologies woven from Cuba for more than 60 years towards the rest of the continental hemisphere. Today, in the 21st century, we see how those same ideologies that caused the Second World War and the most horrendous genocides known to humanity continue to be used by demagogues who call themselves revolutionary leaders, changing constitutions and economic models. Without a doubt, by not taking forceful actions against these socialist forces that have already caused the displacement of millions of people from Cuba, Nicaragua, and Venezuela due to human rights violations, we will very soon have a Latin America tragically filled with major calamities, expelling dozens of millions of immigrants to the few countries of the free world that remain on this continent.

We urge you to remove the Organization of American States from entropy, managing once and for all to expel the Nicaraguan regime from the OAS because it does not comply with the statutes of the inter-American democratic charter. As an OAS ambassador, you can support us and recommend to the United States government the definitive implementation of the **S. 1064 Renacer Act** for the Sandinista regime.

Additionally, and for your information, we are asking the highest authorities of the US government for the following five objectives.

Through this means we urgently request five important objectives to recover individual freedoms, property, democracy, and justice for the people of Cuba, Nicaragua, and Venezuela.

- **First objective: Officially designate the FSLN as a terrorist organization.**

We, the Nicaraguan Americans and the exiles, represented by BTNNOTICIAS.COM, urge the government of the United States of America to recognize the FSLN party structure as a terrorist organization.

The crimes against humanity documented for decades and that continue with great viciousness against Nicaraguans have their roots in the Sandinista National Liberation Front, (as in events of April 2018). This organization of radical ideology controls the entire country, threatening opponents with jail, banishment, or death. Therefore, we request a legislative motion to pass a law that will reveal the terrorist nature of this genocidal force.

We reproach and condemn the support of the Sao Paulo Forum and the Puebla group towards the FSLN dictatorship, whose leaders are José Daniel Ortega and his wife Rosario Murillo. The Sandinista tyranny has given legitimacy to dictatorships like Cuba and Venezuela, protecting coup leaders like Pedro Castillo of Peru, corrupt people such as Cristina Fernández de Kirchner, and above all Vladimir Vladimirovich Putin of Russia and his criminal intervention in Ukraine. The illegitimate president of Nicaragua, along with the Iranian and North Korean governments, recognized the territories usurped from Ukraine by Vladimir Putin and his mercenaries, contradicting and challenging U.S. President Biden's memorandum from September 30, 2022, concerning the illegitimate annexation of the Ukrainian territories by Russia. The FSLN has been a faithful ally of organizations that maintain a low profile within Nicaragua such as Hezbollah, Hamas, and Al-Qaeda, in addition to drug cartels and organized crime.

- **Second objective: Verification of Nicaraguan migrants who have committed crimes and violations of Human Rights, in complicity with the Sandinista dictatorship. These are undesirable aliens who should be deported.**

We request that an exhaustive review of the immigration policy be applied to Nicaraguan migrants who have entered the United States of America, given that infiltrated agents of the Sandinista Front, promoted by the Cuban G2, have emigrated to the United States of America. This, despite having committed Human Rights violations and crimes against civil society, the Catholic Church, and the opposition in Nicaragua.

They have been given immigration refuge without a thorough investigation of the criminal history of these dangerous individuals. Those immigrants who have been participants and accomplices of the Sandinista regime and sons of prominent FSLN politicians and their relatives must be expelled from the United States of America as well. Some form of incarceration for misinformation and fabrication should be decided by the highest authority in the land.

- **Third objective: Review of remittances to countries like Cuba, Nicaragua, and Venezuela.**

We request a thorough audit of the family remittances that are sent to Nicaragua and that have served to sustain and promote the terror regime of the Sandinista dictatorship, as well as that of Castroism in Cuba and Chavismo in Venezuela. This perversely planned strategy has caused these regimes to dedicate themselves to exporting human resources to the United States of America to generate active economic resources (sending family remittances) to the detriment of the quality of life of immigrants in the USA.

Remittances to these countries, especially in the case of Nicaragua, go beyond what is considered a remittance, and have become an investment of a transcendental nature for the economy of the Sandinista dictatorship. This includes outrageously expensive property purchases and paying for goods and services favorable to the regime and its ideological machinery. Therefore, the review, supervision, and control, is a step consistent with the designation of Nicaragua as a real and direct threat against the security of the United States of America.

- **Fourth objective: Temporary freezing of the DR-CAFTA until democracy returns to Nicaragua.**

The FSLN, with its perverse anti-democratic actions, such as the 2021 electoral fraud, the persecution and imprisonment of leaders of the opposition, civil society, and the Catholic Church, has also been involved in a clear meddling and interference in the internal affairs of member countries of the DR-CAFTA, violating international treaties of good coexistence and respect. In the case of Honduras, Sandinismo has managed to infiltrate government ranks with candidates of 21st century socialism, sponsored by the Venezuelan regime.

This portends regional, political, and economic destabilization in the short and long term, since the FSLN terrorist organization has close ties with governments and organizations that are staunch enemies of the United States of America. These associated governments include Venezuela, Iran, China, North Korea, Cuba, and Russia who are all recognized as violators of human rights. For this reason, we urge the freezing of the corresponding quotas from Nicaragua by the free trade agreement, DR-CAFTA, and the United States. The beneficiaries of said trade are exclusively people close to the Sandinista regime, which is controlled by businessmen who pay large sums of money to lobbyists in Washington.

These fiends bend the law for their own purposes; yet such unscrupulous actions are a detriment to democracy, the rule of law and the human rights of the Nicaraguan people. Therefore, severe sanctions are required to stop these unethical magnates, who bear uncanny resemblance to the oligarchs of Russia, in their tracks. We beseech you to please help us in requesting that the Sandinista genocidal regime can no longer finance itself through the free trade agreement known as DR-CAFTA.

- **Fifth objective: A request for Temporary Protected Status for all Nicaraguan citizens who for reasons of political persecution were forced to emigrate to the United States of America.**

According to the Inter-American Declaration of Human Rights, all men are born free and equal in dignity and rights. However, as stated in the Inter-American Declaration of Human Rights, under the Sandinista regime, the right to life, the right to freedom of expression, belief, to live as a family and to live in conditions of security, are systematically violated in Nicaragua. The well-being and healthy, integral development of citizens are constantly threatened. That is why we are requesting temporary work permits for all Nicaraguan immigrants who have arrived in the United States while fleeing the oppressive Sandinista regime.

This is for purely humanitarian reasons and to avoid harassment and bias against Nicaraguan immigrants who are already in the United States. Not giving them this opportunity to work legally and contribute to our economy would expose them to discrimination, mistreatment, and humiliation when they look for a job to survive.

We urge the authorities, representatives, mayors, senators, governors, and the president of the United States, to proclaim their solidarity with the Nicaraguan citizenry, so that temporary protection status can be granted for humanitarian reasons.
